### RESOLUTION REQUESTING THE PHILIPPINE RED CROSS TO ESTABLISH A BLOOD BANK IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

**"WHEREAS**, pursuant to Republic Act No. 7719, also known as the National Blood Services Act of 1994, promotes voluntary blood donation and to regulate blood banks, it aims to inculcate public awareness that blood donation is a humanitarian act;

**"WHEREAS**, Bulalacao is a 3<sup>rd</sup> class municipality hounded with financial constraints located at the southernmost tip of the province of Oriental Mindoro, has a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that uplift the general health condition of the people;

**"WHEREAS**, for the past years, the local government and different organizations in Bulalacao had been taking initiatives in conducting bloodletting activities within the municipality that has been actively participated by its community, thus it still has no blood bank or in its adjacent municipalities which can cater services in collecting and supplying needed bloods for patients;


"WHEREAS, because of its location, it is unfortunate that in times of emergencies and/or life-and-death situations its ailing patients need to have a long travel to the city proper which is the Calapan City just to sustain their medical attentions, it is reasonable and advantageous not only for this municipality but also to adjacent municipalities to establish a blood bank that would positively be a source of hope and life to its people; Now, therefore, be it...
