**RESOLUTION EXPRESSING STRONG SUPPORT OF THE LOCAL
GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO THE
PNP BILLS IN THE 19TH CONGRESS OF THE PHILIPPINES**

"WHEREAS, during the 17th and 18th Congress, the Philippine National Police (PNP) managed to shepherd the enactment of significant legislations aimed at addressing internal and external factors that influence the capacity of the bureau in pursuing its mandate as the premier law enforcement agency in the country. These include the enacted laws on the transfer of the Philippine National Police Academy (PNPA) and the National Police Training Institute to the PNP, the new rank classification in the PNP, the Height Equality Act, the Act which fixed the validity of firearms licenses, and the Private Security Services Industry Act. Thus, for the 19th Congress, it is imperative to pursue legislative measures that will enhance the administrative and operational capabilities of the organization;

2. Restructuring and Strengthening of the PNP (PNP Reorganization Bill)
3. Conferring the Cadets of the PNPA the Status of Government Employees

5. Revitalization and Capability Enhancement of the Philippine National Police ("RACE" Bill)
6. Free Legal Assistance to Military and Uniformed Personnel
7. Amending the Educational Requirement of the PNP Applicants (Amendment of Section 33 of RA No. 6975)
8. Amendment of Sec. 4 of RA No. 10883 or the "New Anti-Carnapping Act of 2016"
9. Field Training Program of Police Trainees
10. Increasing the Quota Requirements of PNP Female Officers
11. Strengthening the Recruitment, Selection, Appointment of PNP Uniformed Personnel
12. Magna Carta for the Non-Uniformed Personnel in Military and Uniformed Agencies




