RESOLUTION NO. 21-01-003

RESOLUTION EXPRESSING THE DEEPEST SYMPATHY AND CONDOLENCES OF THE LOCAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO TO THE BEREAVED FAMILY OF THE LATE FORMER CONGRESSMAN REYNALDO "RU" V. UMALI

"WHEREAS, that morning of January 7, 2021 fated to be the last moments of the former Representative of the 2nd District of Oriental Mindoro as he departed to death and reunited with our Almighty God which caused a deep void of sadness to his family, friends, and constituents;

"WHEREAS, Congressman RU, as he was fondly called to by his supporters, served as 2nd District Representative of Oriental Mindoro for 3 consecutive terms from 2010 to 2019; his most recognized accomplishment in the field of legislation was when he passed the House Bill No.s 00290 and 03738 entitled "An Act to Establish the Oriental Mindoro Special Economic Zone and Freeport in the Province of Oriental Mindoro, creating for this purpose the Oriental Mindoro Special Economic Zone and Freeport authority, appropriating funds thereof and for other purposes" and "An Act providing for the construction, operation and maintenance of the Mindoro-Batangas Nautical Bridge-Highway, linking Mindoro Island to Batangas City, and providing for its implementation under the provision of Republic Act No. 6957, otherwise known as the Build-Operate-Transfer Law", respectively;

"WHEREAS, Congressman RU has acquiesced to the belief that "Power Proceeds Development", as a lawyer and an economist he had capitalized on his profession and years of experience as public servant to effectively served and set development goals particularly in boosting the Agro-Tourism of the Province of Oriental Mindoro, all of his works and achievements did not go unnoticed as he became a recipient of the 2017 Distinguished Bedan Award for Government Service and the 2017 Ulirang Ama Award for Government and Public Service;

"WHEREAS, Congressman RU, was a warrior of hope and courage as he fought enormously to stage 4 liver cancer and COVID-19, but his battle has ended as he suffered to a cardiac arrest and died at the age of 63 years old;
