**ORDINANCE NO. 13-01-130**

**IMPOSING RENTAL OF NICHE COMPARTMENTS IN THE MUNICIPAL CEMETERY OF BULALACAO, ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** There shall be collected the rental fee for lease of five (5) years for every niche compartments the amount of One Thousand Five Hundred Pesos (Php1,500.00);

**SEC. 2.** The fee imposed in this Ordinance shall be paid to the Municipal Treasurer upon application for a burial permit prior to the interment of the deceased.

**SEC. 3.** In case a lessee intends to renew the lease after its termination, he must inform the Municipal Treasurer within 30 days before the expiry date of the lease, otherwise the remains of the deceased shall be transferred to a common burial chamber.

It shall be the duty of the Municipal Treasurer to prepare and submit to the Municipal Mayor a list of the leases that are to expire five (5) days prior to the expiration date. The Municipal Treasurer shall send a reminder to the lessee of the expiration of his lease, two weeks prior to the expiration date of the lease.

**Sec. 4.** All ordinances inconsistent hereof are hereby repealed, modified accordingly.


**Sec. 5.** Any violation hereof shall be punished by a fine of Php2,000.00 or an imprisonment of 4 months or both such fine and imprisonment at the discretion of the Court.


**Sec. 6.** This Ordinance shall take effect ten (10) days after its posting.

**ENACTED** this 3<sup>rd</sup> day of January 3, 2013, Bulalacao, Oriental Mindoro.


