**SPECIAL ORDINANCE NO. 06-10-20**

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO DECLARE CERTAIN PORTION OF THE COMMUNAL FOREST AS PASTURE LAND FOR GOAT RAISING PROGRAM WITHIN THE MANGYAN SETTLEMENT AREA AT LIPSONG, POBLACION BULALACAO, ORIENTAL MINDORO WITH THE PROVISION THAT THERE SHALL BE A MEMORANDUM OF AGREEMENT BETWEEN THE LOCAL GOVERNMENT UNIT AND THE BENEFICIARY**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

**SECTION 1. STATEMENT OF POLICY.** In the furtherance of self-sufficiency and independence of the local community and in order to promote and uplift the socio-economic status of our indigenous people.

**SECTION 2. REGULATED ACTS.** The portion assigned as Mangyan Settlement Area situated at Lipsong, Poblacion, Bulalacao, Oriental Mindoro may be used as goat raising territory wherein settlers thereat may make use of the land as pasture land for the said stock of animal provided that it shall not hamper or destroy the campaign of the municipality towards a balance ecology particularly those already implemented like community reforestation.

**SECTION 3. ADMINISTRATIVE PROVISIONS.**

- i. Any person that should like to use the area must seek clearance from the barangay and the corresponding permit from the Municipal Agricultural Office (MAO);
- ii. The use of granted parcel of land must be coupled with a Memorandum of Agreement between the Municipal Government represented by the Municipal Agricultural Officer and the Interested Party stipulating therein the provisions and conditions, terms and agreement which shall be prepared by the same office without prejudice to the rights and privileges of the government;
- iii. The mode and terms of agreement shall be prepared by MAO and to be submitted to the Office of the Municipal Mayor and the Sangguniang Bayan Office for review and approval and shall render report of the same within thirty (30) days from the approval of this ordinance.

**SECTION 4.** This special ordinance shall take effect immediately.
