SPECIAL ORDINANCE NO. 08-02-05

TEMPORARILY CLOSING TEMPLANZA, CONTRERAS AND PANTILO STREETS AT POBLACION, BULALACAO, ORIENTAL MINDORO

SPONSOR: Councilor Leonardo A. Andallon
CHAIRMAN: Committee on Public Utilities and Facilities

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

SECTION 1. In order to accommodate the selling of goods, merchandise, foodstuffs, commodities or articles of commerce by transient businessmen or traders to the general public in celebration of Poblacion Barangay Fiesta, Templanza, Contreras and Pantilo Streets at Poblacion, Bulalacao, Oriental Mindoro are hereby temporarily closed starting from February 14 up to February 29, 2008;

SECTION 2. A certain amount as maybe determined by the Municipal Government of Bulalacao shall be charged to any person who stays in excess of fifteen (15) days;

SECTION 3. Any person violating this ordinance shall suffer the penalty of six (6) months imprisonment or shall be fined by an amount of Two Thousand Five Hundred Pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court;
