## SPECIAL ORDINANCE NO. 06-03-04

**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, ERNILO C. VILLAS TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL COMMISSION ON INDIGENOUS PEOPLES (NCIP), MANGYAN MISSION, INC., KAPULUNGAN PARA SA LUPAING NINUNO, INC. (KPLN) AND PINAGKAUSAHAN HANUNUO SA DAGA GINURANG (PHADAG) FOR THE IMPLEMENTATION OF DIRECT APPLICATION FOR CERTIFICATE OF ANCESTRAL DOMAIN TITLE OF HANUNUO MANGYANS BASED ON THE PROVISIONS OF REPUBLIC ACT 8371 (IPRA) AND OTHER PERTINENT LAWS, RULES AND REGULATIONS**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** In order to implement the Direct Application for Certificate of Ancestral Domain Title of Hanunuo Mangyans based on the provision of Republic Act 8371 (IPRA) and other pertinent laws, rules and regulations, the Municipal Mayor Ernilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with the National Commission on Indigenous Peoples (NCIP), Mangyan Mission, Inc., Kapulungan Para sa Lupaing Ninuno, Inc. (KPLN) and Pinagkausahan Hanunuo sa Daga Ginurang (PHADAG);
