**ORDINANCE NO. 08 - 05- 079**

**IMPOSING FEES ON THE USE OF FACILITIES IN THE  
MUNICIPAL FISH LANDING PORT OWNED AND OPERATED BY  
THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL  
MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** There shall be collected from every person, natural or juridical, that shall use the facilities of the Municipal Fish Landing port, owned and operated by the Municipality of Bulalacao, Province of Oriental Mindoro, the following fees:

**SEC. 2.** The fee imposed herein shall be paid to the Municipal Treasurer upon application for a Mayor's permit and issuance thereof

**SEC. 3.** Ordinances inconsistent hereof is hereby repealed, modified accordingly;

**SEC. 4.** Any violation of this Ordinance shall be punished by a fine of not less than One Thousand Pesos (Php1,000.00) but not more than Five Thousand Pesos (Php5,000.00) or imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court;






