**SPECIAL ORDINANCE NO. 10-11-89**

**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES OR WITH OTHER GOVERNMENT FINANCIAL LENDING INSTITUTION TO SECURE LOANS IN THE AMOUNT OF FIFTEEN MILLION PESOS (PHP15M) TO BE USED FOR THE IMPLEMENTATION OF VARIOUS PROGRAMS AND PROJECTS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:





ENACTED this 17<sup>th</sup> day of November, 2010, Bulalacao, Oriental Mindoro.


