SPECIAL ORDINANCE NO. 13-07-46

SPECIAL ORDINANCE PRESCRIBING CRITERIA TO QUALIFY TO ESTABLISH, OPERATE AND MAINTAIN A COCKPIT IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to provide order and regularity in the issuance of license or grant of franchise to establish, operate and maintain a cockpit in this Municipality, the following requirements or criteria must be met by the applicant:

- i. Bona fide resident of Bulalacao, Oriental Mindoro for at least a year as certified by the barangay captain concerned;
- ii. Registered voter in the Municipality of Bulalacao, Oriental Mindoro;
- iii. Owner or a breeder of gamecocks. One is considered to be a breeder under this Ordinance if one owns at least 150 heads of fighting cocks. Has at least five (5) years experience of undergoing Province wide Derby/Cockfighting activity;

- iv. The proposed cockpit shall adhere to the limitations provided by existing zoning ordinance, National Building Code and all other existing related laws pertinent to cockfighting;
- v. Shall have no pending obligations in terms of taxes, fees, liens whatsoever in the Office of the Municipal Treasurer.
- vi. An applicant must be a member of Breeding Association such as United Mindoro Gamefowl and Breeders Association (UMIGBA) to ensure the connection of the applicant to other cockpit operators.


SEC. 2. All ordinances/resolutions inconsistent hereof are hereby repealed/modified accordingly.


SEC. 3. This Special Ordinance shall take effect immediately.


