SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ORIENTSTAR CONSTRUCTION INC., REPRESENTED BY MR. RONALD C. MANALO, GENERAL MANAGER HEREINAFTER REFERRED TO AS THE CONTRACTOR FOR THE CONSTRUCTION OF CAMBUNANG TO NAPISIAN AND CAMBUNANG TO COGON MALAPAD FARM TO MARKET ROADS SITUATED IN BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO

ENACTED this 7th day of March, 2013, Bulalacao, Oriental Mindoro.


