SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REPRESENTED BY ENGR. MAGTANGGOL C. ROLDAN, DISTRICT ENGINEER, DPWH DISTRICT OFFICE, ROXAS, ORIENTAL MINDORO FOR THE IMPLEMENTATION OF THE REPAIR AND REHABILITATION OF BARANGAY CAMBUNANG ROAD INCLUDING THE BRIDGE IN THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND PESOS (PHP750,000.00) AND RATIFYING THE SAME AGREEMENT


BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:




SEC. 2. This Special Ordinance shall take effect immediately.
