ORDINANCE NO. 16-08-165

AN ORDINANCE AUTHORIZING THE MUNICIPAL TREASURY OFFICE TO DEDUCT THE DULY COMPUTED BUSINESS TAX FROM PAYMENT OF SERVICES RENDERED OR PRODUCTS DELIVERED TO THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO BY ANY BUSINESS ESTABLISHMENT HAVING LAWFUL ENGAGEMENT WITH THE LATTER

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. Pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Bulalacao, Oriental Mindoro may adopt strategies and policies deemed necessary for efficient and effective tax collection.

SEC. 2. AUTHORIZED ACTS. The Municipal Treasury Office is hereby authorized to deduct the duly computed business tax from payment of services rendered or products delivered to the Local Government Unit of Bulalacao, Oriental Mindoro by any business establishment having lawful engagement with the latter, provided that such computation is based on provision stipulated in Article B of the Revised Revenue Code of 2004 of the Local Government Unit of Bulalacao, and provided further that the situs of the tax has been significantly considered in such computation. It shall be the duty of the Municipal Treasury Office to coordinate with the manager, owner, operator, or duly authorized representative of the establishment at least one (1) week prior to the deduction.

The amount of business tax to be deducted from payment due to winning contractors of infrastructure and other projects shall be based on the same percentage of payment with progress billing as the reference.

The Municipal Engineering Office and other offices and as much as possible all employees and officials of the Local Government Unit of Bulalacao shall periodically provide necessary information to the Municipal Treasury Office with focus on taxable business activities conducted within the jurisdiction of this Municipality by any business person, association, corporation, enterprise or establishment.

SEC. 3. PENALTY. Any employee or officer of the Local Government Unit of Bulalacao who shall violate or who shall cause the non-implementation of this Ordinance shall be charged, heard and penalized administratively.

SEC. 4. REPEALING CLAUSE. Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

SEC. 5. EFFECTIVITY. This Ordinance shall take effect immediately
