**RESOLUTION RECOMMENDING TO THE MUNICIPAL MAYOR TO
IMPOSE A PREVENTIVE SUSPENSION FOR SIXTY (60) DAYS
AGAINST PUNONG BARANGAY ADESAR U. CALINOG IN VIEW OF
FORMAL INVESTIGATION CONDUCTED BY THE SANGGUNIANG
BAYAN IN ACCORDANCE WITH MUNICIPAL ORDINANCE NO. 23-01-
341**

"WHEREAS, on January 25, 2023, a complaint with annexes was received by the Secretary to the Sanggunian filed by Barangay Kagawad of Benli, namely: Henry R. Magtanggol, Joy J. Badok, Tuna Y. Aykid, Oyong C. Maligday, Bernie K. Lingin, Bonglay M. Saon, Aturni L. Tikling, Oding A. Antawan and Ducot A. Lingin against Punong Barangay of Benli, G. Adesar U. Calinig and Salome A. Ungkay, Ingat-Yaman of the same barangay;

"WHEREAS, pursuant to Section 1, Rule 7 of Municipal Ordinance No. 23-01-341, the SB Committee as a Whole summoned the parties to a preliminary conference on January 30, 2023 involving Adm. Case No. SB-23-001, For: Dishonesty, Grave Misconduct Unbecoming of Public Officials, Violation of R.A. 3019, R.A 6713 and R.A. 9184 filed against Punong Barangay Adesar U. Calinog of Barangay Benli;

"WHEREAS, on February 23, 2023, a preliminary conference was conducted by the SB Committee as a Whole where both the respondents and the complainants appeared and agreed for a formal investigation to consider the simplification of the issues, the possibility of obtaining stipulation or admission of facts and of documents, specifically affidavits and depositions, the limitation of the number of witnesses, dates of hearing and such other matters as may aid the prompt disposition of the case;

"WHEREAS, pursuant to Section 1, Rule 6 of Municipal Ordinance No. 23-01-341, when the evidence of guilt is strong, and given the gravity of the offense, there is a great probability that the continuance in office of the respondents could influence the witnesses or pose a thrust to the safety and integrity of the records and other evidence, the Committee may recommend to the Sanggunian that the respondents be placed under preventive suspension which shall not extend beyond sixty (60) days;

"WHEREAS, Section 2 likewise states that upon receipt of the resolution of the Sanggunian directing preventive suspension to the respondents, the Municipal Mayor shall issue the order imposing the preventive suspension to the respondent without delay; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED To: Recommend to the Municipal Mayor to impose a preventive suspension for sixty (60) days against Punong Barangay Adesar U. Calinog in view of formal investigation conducted by the Sangguniang Bayan in accordance with Municipal Ordinance No. 23-01-341;




