**“WHEREAS**, Section 3 of Republic Act No. 7883 refer Barangay Health Worker as a person who has undergone training programs under any accredited government and non-government organization and who voluntarily renders primary health care services in the community after having been accredited to function as such by the local health board in accordance with the guidelines promulgated by the Department of Health (DOH);

**“WHEREAS**, Bulalacao is a 3<sup>rd</sup> class municipality located at the southernmost tip of the province of Oriental Mindoro, has a population of 44,366 based on 2020 census, has a municipal government that uplift the general health condition of the people;

**“WHEREAS**, Bulalacao has 158 active barangay health workers who are not yet accredited due to lack of trainings and/or seminars, thus, many of the assistance and incentives from the government are unfortunately not being received by them;

**"WHEREAS,** the Municipal Health Office of Bulalacao will be conducting a 5-day training program and seminar for these 158 barangay health workers to comply in the completion of their accreditation, however, due to limited budget, it is hoping for technical and financial support from higher agencies;






