**AN ORDINANCE DECLARING EVERY LAST FRIDAY OF THE MONTH
OF APRIL AS THE BULALACAO DAY IN MUNICIPALITY OF
BULALACAO, PROVINCE ORIENTAL MINDORO**

WHEREAS, the Philippines has the most number of celebrations or
feasts to commemorate an event for thanksgiving for the blessings bestowed
upon the people and the community;

WHEREAS, Bulalacao, a coastal Municipality of a great cultural
significance, a center of rich diversity of exquisite forest, fishery and marine
resources. In addition, Bulalacao is an emerging tourist destination, offering
a peaceful environment and provide some respite from work.

WHEREAS, considering its significance to the people of Bulalacao, and to preserve our culture and traditions in honor of our past and present generations, the Sanggunian deemed it very important to name and identify the celebration;

WHEREAS, festival as one of the highlights of Bulalacacao Day will help for the promotion and development of tourism industry;

WHEREAS, this Municipal Ordinance declares every last Friday of the month of April as Bulalacao Day which shall be celebrated annually through holding of annual festival;

WHEREAS, the said date is one of the best choices because it is summer vacation where, many tourist can celebrate, visit and experience the Bulalacao Day;

WHEREAS, Section 447 of RA 7160 otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan, as the Legislative Body of the Municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the Municipality and its inhabitants and pursuant to Section 16 of the same Code provides that the Local Government Unit shall exercise the powers expressly granted for the effective and efficient governance;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

Section 1. Title. This Ordinance shall be called "Bulalacao Day Ordinance"

Section 2. Administrative Provision.

A. "Bulalacao Day" of the Municipality of Bulalacao, Oriental Mindoro shall be held on every last Friday of the Month of April and every year thereafter.

Section 3. Funding Support.

This event shall become a regular annual activity of Bulalacao. Funds shall be allocated annually by the Municipality to defray the expenses for the conduct of various activities during the celebration.


Section 4. Repealing Clause. All ordinances, rules and regulations or parts thereof in conflict or inconsistent herewith are hereby repealed or modified accordingly.


Section 5. Separability Clause. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.


