**ORDINANCE NO. 08-09-086**

**FIXING THE RATE OF PAYLOADER AND BACKHOE SERVICES OWNED AND MAINTAINED BY THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE AMOUNT OF PHP40.00 PER CUBIC METER**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The rate of payloader and backhoe services is hereby fixed in the amount of Forty Pesos per cubic meter (Php40.00/cubic meter).

**SECTION 2.** It is understood that the LGU shall be responsible for the fuel of payloader and backhoe while carrying the task. The loading can only be conducted when there is an operation in the site and on idle time or when the loader is not being used during the operation.

**SECTION 3.** Violation of this Ordinance shall be fined of Php2,500.00 or imprisonment of six (6) months or both at the discretion of the Court.
