EARNESTLY REQUESTING THE HONORABLE PIA CAYETANO, SENATOR, REPUBLIC OF THE PHILIPPINES TO INTERVENE WITH ANY CHARITABLE INSTITUTIONS SUCH AS THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) AND THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) FOR THE ALLOCATION OF ONE (1) UNIT OF AMBULANCE FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was declared as Pro-Poor Municipality pursuant to Executive Order No. 370;

"WHEREAS, it is understood that by virtue of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, the delivery of basic health services has been devolved to the LGU concerned that it should exert effort and strategies on health programs to ensure the good health of its people;

"WHEREAS, the Municipal Health Unit of the Municipality of Bulalacao is manned by only one (1) physician, two (2) nurses and few number of midwives that it shall be more responsive and effective in the delivery of health services to the residents if sufficient medicines and medical facilities such as that of an ambulance are available; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Pia Cayetano, Senator, Republic of the Philippines to intervene with any charitable institutions such as the Philippine Charity Sweepstakes Office (PCSO) and the Philippine Amusement and Gaming Corporation (PAGCOR) for the allocation of one (1) unit of ambulance for the Municipality of Bulalacao, Province of Oriental Mindoro;


