## **RESOLUTION NO. 05-08-112**

**EARNESTLY REQUESTING THE HONORABLE PIA CAYETANO, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF ONE (1) UNIT 3-CLASSROOM BUILDING AT BULALACAO NATIONAL HIGH SCHOOL MAUJAO EXTENSION CLASS SITUATED AT BARANGAY MAUJAO, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO**

**"WHEREAS,** the Municipality of Bulalacao, Oriental Mindoro has only one secondary school at the town proper to cater students coming from its 15 component barangays which are separated by high mountain ranges and wide sea waters;

**"WHEREAS,** its geographical feature deprived the opportunity for elementary graduates to continue studying in the secondary school that through the combined efforts of the Local Government Unit of Bulalacao with other concerned agencies, the Bulalacao National High School Maujao Extension Class was established almost four (4) years ago;

**"WHEREAS,** the Maintenance and Other Operating Expenditures including the salaries of teachers of the school mentioned above are presently financed by the LGU that other facilities and amenities needed most particularly additional classroom building could not be readily provided due to limited funds;

"WHEREAS, the abovementioned request is believed to be realized only through the benevolence of Senator Cayetano; Now, therefore, be it
