RESOLUTION NO. 05-08-102

EARNESTLY REQUESTING THE HONORABLE SERGIO OSMEÑA, III, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF 3-CLASSROOM BUILDING WITH COMPLETE FACILITIES AND AMENITIES AT TAMBANGAN ELEMENTARY SCHOOL AT SITIO TAMBANGAN, BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO TO BE NAMED AS SENATOR SERGIO OSMEÑA TYPE SCHOOL BUILDING

"WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all;

"WHEREAS, Tambangan Elementary School building becomes dilapidated which poses danger to lives and properties particularly during the onslaught of bad weather condition;

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Sergio Osmeña, III, Senator, Republic of the Philippines to allocate the necessary funds for the construction of 3-classroom building with complete facilities and amenities at Tambangan Elementary School at Sitio Tambangan, Barangay San Juan, Bulalacao, Oriental Mindoro to be named as Senator Sergio Osmeña Type School building;
