SOLIMAN, SECRETARY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT TO CONSIDER THE INCLUSION OF NON-4P's POOR FAMILIES IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, poverty remains the most important developmental problem of the country today;

"WHEREAS, with the introduction of "basic need concept", redefines poverty to cover not just the shortage of income but the lack of access to health and other social services; the State cognizant of the need to alleviate the lot of those living under the poverty threshold adopted the so-called Pangtawid Pamityang Pilipino Program (4P's);


"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was chosen as one of the beneficiary municipalities and; based on the Community Based Monitoring System (CBMS) survey results, there are 5,337 households living under the poverty line, only 3,974 are 4P's beneficiaries and the remaining 1,359 look for their inclusion in the said Program;

"WHEREAS, inclusion of the remaining non members to the 4P's program shall redound to the socio-economic benefits of the poor inhabitants of this Municipality;






