EARNESTLY REQUESTING THE HONORABLE PROCESO J. ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO GRANT THE AMOUNT OF FIVE MILLION PESOS (PHP5M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF BARANGAY CABUGAO PROPER TO SITIO CAMBAYANG, BARANGAY CABUGAO THREE KILOMETER (3km) FARM TO MARKET ROADS
