RESOLUTION NO.12-10-086

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. ERNILO C. VILLAS TO SUBMIT A LETTER OF INTENT FOR THE MUNICIPALITY OF BULALACAO TO AVAIL OF THE AGRARIAN REFORM COMMUNITIES PROJECT II - PERFORMANCE-BASED GRANT (ARCP II-PBG), ENTER INTO AND EXECUTE THE CONTRACT TO REFORM/CAPACITY DEVELOPMENT GRANT (CDG) MOAS WITH DEPARTMENT OF AGRARIAN REFORM (DAR) AND MUNICIPAL DEVELOPMENT FUND OFFICE (MDFO) AND TO AUTHORIZE THE DAR, MDFO AND PERFORMANCE BASED GRANT SYSTEM (PBGs) COMMUNITIES TO CONDUCT ASSESSMENT AND ACCESS RELEVANT DOCUMENTS AND TO PROVIDE APPROPRIATION FOR EQUITY FOR THE CAPITAL GRANT

"WHEREAS, the Agrarian Reform Communities Project II (ARCP II) is a six-year development project of the Department of Agrarian Reform (DAR) financed by a loan from the Asian Development Bank under Loan No. 2465-PHI and OPEC Fund for International Development (OFID) under Loan No. 1225P;

"WHEREAS, the Project seeks to reduce poverty in selected ARCs and ARC Clusters in nineteen (19) Project provinces spread across six (6) regions and to enable the Agrarian Reform Beneficiaries (ARBs) in these areas to have sustained improvements in incomes and quality of life;

"WHEREAS, based on the loan agreement between the Government of the Philippines and Asian Development Bank, the ARCP II shall also extend grants to project's participating, LGUs using, the Performance Based Incentive Policy (PBIP) administered by the Performance Based Grant System (PBGS) Steering, Committee (SC) chaired by the Department of Finance (DOF);

"WHEREAS, under the PBIP, the performance based grant could be in the form of Capital Grant (CG) and Capacity Development Grant (CDG);

"WHEREAS, as beneficiary of ARCP II, the Municipality of Bulalacao, Province of Oriental Mindoro is entitled to an additional incentive amounting to 20% of the approved Rural Infrastructure Subproject's Contract Cost but not to exceed Php6.5 million for 1st & 2nd class, Php5 million for 3rd & 4th class and Php4 million for 5th & 6th class municipalities;

"WHEREAS, as a prequalifications and eligibility requirement, there is a need to authorize the Mayor, Honorable Ernilo C. Villas or his successor, to submit a Letter of Intent to avail of the ARCP II – PBG, enter into and execute the PBGS Contract tto Reform/CDG Memorandum of Agreements (MOAs) with DAR and MDFO;

"WHEREAS, an equity contribution equal to ten percent (10%) of the Capital Grant will be required from the Municipality of Bulalacao to established better LGU stake and commitment;

NOW, THEREFORE, upon motion of Honorable Gideon B. Abuel duly seconded by Honorable Senen C. Familara, be it


RESOLVED AS IT IS HEREBY RESOLVED; To: Grant authority as it is hereby granted authority, the Municipal Mayor, Honorable Ernilo C. Villas, to submit a Letter of Intent to avail, prepare, enter into and execute MOA for Contract to Reform and MOA for CDG with DAR and MDFO, and to provide appropriation for the required equity for the PBGS Capital Grant;


RESOLVED FURTHER, to authorize DAR, MDFO and PBGS Committees to conduct assessment and access relevant documents for the purpose of providing the PBG;




