EARNESTLY REQUESTING THE DEPARTMENT OF AGRICULTURE (DA) AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO ALLOCATE THE AMOUNT OF FORTY MILLION PESOS (PHP40M) TO BE USED FOR THE CONCRETING OF FARM TO MARKET ROAD FROM THE CONCRETE ROAD SITUATED AT BARANGAY CAMBUNANG TO SITIO F.F. CRUZ, NAPISIAN, BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 1, Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the Nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;

"WHEREAS, Barangay Cambunang, Bulalacao, Oriental Mindoro is a vast agricultural land producing large volume of rice, corn, garlic, onions and other varieties of fruits and vegetables that a good transportation system shall provide the farmers access to the market, preserving the quality of the products for a fair market value;

"WHEREAS, the concreting of the farm to market roads mentioned above would surely push the implementation of programs and projects geared towards the social and economic development of our brothers and sisters living in the countryside; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Department of Agriculture (DA) and the Department of Public Works and Highways (DPWH) to allocate the amount of Forty Million Pesos (Php40M) to be used for the concreting of Farm to Market Road from the concrete road situated at Barangay Cambunang to Sitio F.F. Cruz, Napisian, Barangay Cambunang, Bulalacao, Oriental Mindoro;


