**RESOLUTION NO. 21-12-382**

**RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THRU SECRETARY MARK A. VILLAR TO ALLOCATE TEN MILLION PESOS (PHP10,000,000.00) TO BE USED FOR THE REPAIR, CONSTRUCTION AND REHABILITATION OF THE DRAINAGE CANAL ALONG THE ROADS OF BARANGAY POBLACION AND CAMPAASAN, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**"WHEREAS**, the Municipality of Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**"WHEREAS**, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

**"WHEREAS**, the provision of connecting drainage canal along the roads of Barangay Poblacion and Campaasan in the Municipality of Bulalacao would certainly ensure uninterrupted discharge of water throughout the drainage season and prevent flooding especially in the agriculture and coastal areas of two barangays;

**"WHEREAS**, the allocation of funds from DPWH would definitely support and help the repair, construction and rehabilitation of the intended drainage canal that will uphold structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...


