DUE TO DEVASTATION BROUGHT BY TYPHOON PAENG**

“WHEREAS, pursuant to Section 447 (1) (iv) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan as the legislative body of the municipality mandates to enact ordinances, approved resolutions and appropriate funds for the general welfare of the municipality such as but not limited to the adoption of measures to protect the inhabitants of the municipality from the harmful effects of man-made and natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

"WHEREAS, Section 16 of Republic Act No. 10121 also known as the "Philippine Disaster Risk Reduction and Management Act of 2010", the National Council shall recommend to the President of the Philippines the declaration of a cluster of barangays, municipalities, cities, provinces, and regions under a state of calamity, and the lifting thereof, based on the criteria set by the National Council, the President's declaration may warrant international humanitarian assistance as deemed necessary, the declaration and lifting of the state of calamity may also be issued by the local sanggunian, upon the recommendation of the LDRRMC, based on the results of the damage assessment and needs analysis;


"WHEREAS, from October 29 to 31, 2022, the Municipality of Bulalacao was hit by Typhoon Paeng which brought strong winds and heavy rains to the entire municipality for three consecutive days wherein a total of 47 residential houses were damaged, a massive loss in infrastructures with estimated cost of PhP475,200,000.00 and in agriculture/fisheries with estimated cost of PhP102,192,580.00, and a total of 1048 families and 3819 individuals were evacuated that led to social and economic losses of the municipality as a whole;


"WHEREAS, this Sanggunian urges to impose the declaration of the State of Calamity of the entire municipality to hasten the recovery, relief, and rehabilitation efforts of the local government and the private sectors, and to effectively control the prices of basic commodities and utilize appropriate funds for the continuous provision of basic services to the affected residents; Now, therefore, be it...


