WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that local government unit can exercise powers necessary for its efficient and effective government, essential to the promotion of the general welfare of its constituents;

WHEREAS, Section 106 of the same law states that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian. For the purpose, the development council shall assist the corresponding sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

WHEREAS, various programs and activities were determined to drive the socio-economic development as identified by the different sectoral divisions such as the General Services, Social Services and Economic Development Sector and other services for the provision of an effective and efficient range of works, services and facilities that fulfill the needs and expectations of the community;


