**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**"WHEREAS**, Bulalacao, a 3<sup>rd</sup> class municipality with a population of 39,107 based on 2015 census, has 15 barangays and total agricultural land area of 10,325.80 hectares with 6,016 registered individuals employed in the agricultural sector;

**"WHEREAS**, Bulalacao has a tropical climate type conducive to planting of staple crops such as rice and corn including garlic, onions and varieties of vegetables and fruits transported to Manila and nearby provinces;


**"WHEREAS**, a corn combine harvester is an all-around machine that efficiently separates the kernel from its husk, silk, and ear on a singular process, it ramps the harvesting process and yields higher output of corn harvest over the manual method which can prolong to a number of days or week;

**"WHEREAS**, at the present time there is no corn combine harvester available in the Municipality of Bulalacao, the provision of this machine would be beneficial to the corn farmers that are having difficulties in the harvesting processes such as in reaping, threshing and winnowing the products; Now, therefore, be it...


