## RESOLUTION NO. 20-11-462

**EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT THRU SECRETARY WENDEL AVISADO TO ALLOCATE THE AMOUNT OF ONE HUNDRED EIGHTY MILLION PESOS (PhP180,000,000.00) TO BE USED FOR THE CONSTRUCTION AND IMPROVEMENT OF VARIOUS INFRASTRUCTURE IN SUPPORT OF NATIONAL SECURITY (NTF-ELCAC), AND THE CONSTRUCTION AND OPENING OF F.F. CRUZ- UMABANG- BAILAN- BENLI PROPER LOCAL ACCESS ROAD ALL SITUATED IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, the Municipality of Bulalacao is on its way to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both government and private sectors are applied and gathered together to deliver the best positive outcome;

**“WHEREAS**, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 39,107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**“WHEREAS**, roadways serve a vital purpose in any places, it allows people and vehicles to traverse a diverse range of lands so that they can reach their destination without any hindrance and it is an important form of infrastructure that is ideal and necessary in the areas;

**“WHEREAS**, Sitio F.F. Cruz, Umabang, Bailan and Benli Proper in Barangay Cambunang and Benli do not have definite connecting roads that the construction of the roadways will make ease to people;

**"WHEREAS,** Sitio F.F. Cruz, Umabang, Bailan and Benli Proper in Barangay Cambunang and Benli are homes to Hanunuo Mangyans that the present Administration joined efforts and resources to provide them necessary infrastructural facilities such as a functional roadways that shall promote livelihood, enhance social and economic upliftment to boost their moral by giving them enough opportunities to become active and productive members of the community;

**"WHEREAS,** the provision of concrete roads from Sitio F.F. Cruz, Umabang, Bailan and Benli Proper will also support counter insurgency in conveying awareness to people showing that the Government is focused in giving welfare and development in the countryside helping them achieve their goals and aspirations for their families and society as a whole;

**NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED,** To: earnestly request the Department of Budget and Management thru Secretary Wendel Avisado to allocate the amount of one hundred eighty million pesos (PhP180,000,000.00) to be used for the construction and improvement of various infrastructure in support of National Security (NTF-ELCAC), and the construction and opening of F.F. Cruz-Umabang- Bailan- Benli Proper local access road all situated in the Municipality of Bulalacao, Province of Oriental Mindoro.
