RESOLUTION NO. 16-12-182

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2017 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF THREE MILLION ONE HUNDRED FORTY FOUR THOUSAND ONE HUNDRED SEVENTY SEVEN PESOS AND TWENTY EIGHT CENTAVOS (PHP3,144,177.28) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 05-2016 DATED SEPTEMBER 5, 2016

"WHEREAS, Section 57 and Section 447 par (ii) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Poblacion, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2017 showing therein the sources of income and barangay expenditures starting from January 1, 2017 up to December 31, 2017;

"WHEREAS, the Barangay Fund Annual Budget for FY 2017 of Barangay Poblacion was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on December 16, 2016 and was found to be consistent and in accordance with the priority developments projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;

"WHEREAS, Sangguniang Barangay of Poblacion, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;

"WHEREAS, to show that all projects enumerated in the 20% Development Fund, 5% Calamity Fund and 10% SK Fund passed thorough and widely participated deliberations, the Sanggunian requires the submission of the minutes and resolution of the Barangay Development Council and the Barangay Disaster Risk Reduction Management Council which are duly approved and adopted by the Sangguniang Barangay;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 2017 of Barangay Poblacion, Bulalacao, Oriental Mindoro, appropriating the amount of Three Million One Hundred Forty Four Thousand One Hundred Seventy Seven Pesos and Twenty Eight Centavos (Php3,144,177.28) passed under Sangguniang Barangay Appropriation Ordinance No.05- 2016 dated September 5, 2016;


