WHEREAS, typhoons bring strong winds and heavy rains resulting in flooding, widespread damages to houses and infrastructure such as buildings, roads and bridges, great damage to crops, interrupt power and telecommunication services and loss of human lives;

WHEREAS, it can be resulted that Super Typhoon Ursula hit the Municipality of Bulalacao on December 25, 2019 which brought great havoc and misfortune to the residents who were forced to leave their houses and spent Christmas in evacuation centers to ensure their safety particularly those living in coastal barangays;

WHEREAS, precautionary measures should be implemented during the onslaught of typhoons and one important equipment is the rescue boat for effective response capability of the local government unit to protect lives and properties;
