**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 04-2016 OF BARANGAY SAN ROQUE, REALIGNING THE AMOUNT OF FIFTY FOUR THOUSAND TWO HUNDRED EIGHTEEN PESOS AND NINETY THREE CENTAVOS (PHP54,218.93) TAKEN FROM THE HONORARIUM OF SK AND CASH GIFT TO AUGMENT FUND FOR PRODUCTIVITY ENHANCEMENT INCENTIVES (PEI)**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Approve Appropriation Ordinance No.04-2016 of Barangay San Roque, Realigning the amount of Fifty Four Thousand Two Hundred Eighteen Pesos and Ninety Three Centavos (PhP54,218.93) taken from the Honorarium of SK and Cash Gift to augment fund for Productivity Enhancement Incentives (PEI), with the following recommendations, to wit:

1. That, the granting of PEI shall be in accordance with COA Rules and Regulations;
2. That, provisions of Executive Order No. 201 shall be conformed accordingly with emphasis on Section 6 which states that PEI shall not be given earlier than December 15 of every year;
3. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of San Roque in connection with the implementation of said appropriation ordinance.




