DUQUE, REGIONAL TECHNICAL DIRECTOR, NATIONAL MEAT INSPECTION SERVICE TO ALLOCATE THE AMOUNT OF TWO MILLION PESOS (PHP2M) TO BE USED FOR THE IMPROVEMENTS, REPAIR AND REHABILITATION OF THE MUNICIPAL SLAUGHTERHOUSE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 hat because of financial constraints could not readily implemented important infrastructural projects particularly those which are income generating such as that of a modern slaughterhouse;

"WHEREAS, a modern double "AA" accredited slaughterhouse with upgraded facilities that conform to good Manufacturing Practice (GMP) based on standards set by the National Meat Inspection Service (NMIS) that shall serve the domestic market in profitable in order to enhance the operation and the capability to supply higher quality of meat and meat products;


