"WHEREAS, the National Meat Inspection Service (NMIS) is an organization under the Department of Agriculture where its main role is to ensure that meat being sold in markets are being consumed by the population at large free from disease and potentially dangerous contaminants and micro organisms;

"WHEREAS, in order to safeguard public health when it comes to selling and distribution of meat in the market, the NMIS is tasked to inspect the meat and meat handling facilities in the country and that it has jurisdiction over all slaughterhouses and this could be done through the Designated Meat Inspector in every Municipality

"WHEREAS, to fully ensure the implementation of the NMIS policies and regulations in the proper handling and good hygiene in the slaughterhouse, an orientation or seminar for all persons involved in meat selling, handlers and butchers including slaughterhouse personnel is direly needed; Now, therefore, be it






