**"WHEREAS**, a Cadastral Survey Plan is basically a property boundary survey which is primarily carried out for legal purposes so as to accurately establish land ownership boundaries and usage;

**"WHEREAS**, cadastral surveys are normally conducted in order to identify property owner for it measures site's dimensions, area and boundaries with adjacent sites. It includes the preparation of maps and books from these measurement and are submitted to official registration office for certification;

**"WHEREAS**, cadastral survey is important because it is a basic information for drafting plans involving land by any political unit such as the local government unit in its effort to provide various basic services to the general public within its territorial jurisdiction;

**"WHEREAS**, a cadastral survey of the Municipality of Bulalacao, Oriental Mindoro was conducted several years ago, but sad to say, copy of the Cadastral Survey Plan was not made available up to this time for this Sanggunian to see and confirm, Now, therefore, be it;
