RESOLUTION NO. 20-06-277

EARNESTLY REQUESTING THE COMMISSION ON HIGHER EDUCATION (CHED) TO ALLOCATE ADDITIONAL SCHOLARSHIP SLOTS UNDER TERTIARY EDUCATION SUBSIDY (TES) OR OTHER PROGRAMS FOR STUDENTS OF MINDORO STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY (MINSCAT) BONGABONG CAMPUS BULALACAO EXTENSION FOR SCHOOL YEAR 2020-2021 AND ONWARDS

“WHEREAS, the Commission on Higher Education is a national government agency in charged with promoting relevant and quality higher education, ensuring access to quality higher education, and guaranteeing and protecting academic freedom for continuing intellectual growth, advancement of learning and research, development of responsible and effective leadership, education of high level professionals, and enrichment of historical heritage;

“WHEREAS, Mindoro State College of Agriculture and Technology (MinSCAT) Bongabong Campus Bulalacao Extension, a learning intervention provided by MinSCAT in partnership with the Local Government Unit of Bulalacao, is a significant innovation that provides tertiary education to Bulalacaonons – a first of its kind in this third class municipality;

“WHEREAS, CHED scholarship programs aim to provide assistance to deserving and financially-incapable students preferably the Underprivileged and Homeless Citizens under Republic Act No. 7279, Persons with Disabilities (PWDs) under RA No. 7277 as amended, solo parents and/or their dependents under RA No. 8972, Senior Citizens under RA 9994 and Indigenous People under RA No. 8371, in finishing their tertiary studies;

“WHEREAS, “Education for All” is a flagship program of the LGU of Bulalacao; hence, the opening of MinSCAT Bulalacao Extension. Provision of scholarship grants would entice students, especially the indigenous people, to enroll in said institution;


"WHEREAS, many high school graduates of this municipality were unable to pursue tertiary education because of poverty; they would rather help their parents in farming or fishing in order to help both ends meet;

"NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Commission on Higher Education (CHED) to allocate additional scholarship slots under Tertiary Education Subsidy (TES) or other programs for students of Mindoro State College of Agriculture and Technology (MinSCAT) Bongabong Campus Bulalacao Extension for School Year 2020-2021.


