RESOLUTION NO. 19-08-126

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 03-2019, SUPPLEMENTAL BUDGET FOR FY 2019 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO ENTITLED "APPROPRIATING THE AMOUNT OF SIXTY ONE THOUSAND SEVEN HUNDRED SEVENTY ONE PESOS AND EIGHTY FIVE CENTAVOS ONLY (PhP61,771.85) TAKEN FROM GENERAL FUND TO AUGMENT FUND FOR SUPPORT TO HEALTH SERVICES, SUPPORT TO CHILD DEVELOPMENT & OTHER MOOE UNDER MOOE" OPERATIVE IN ITS ENTIRETY

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Poblacion, Bulalacao, Oriental Mindoro submitted its Supplemental Budget for FY 2019 showing therein the sources and object of expenditures to this Sanggunian for review on July 15, 2019 pursuant to the provisions of Republic Act (R.A.) No. 7160;

"WHEREAS, the Supplemental Budget for FY 2019 of Barangay Poblacion was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on August 27, 2019 and was found to be operative in its entirety with the following recommendations; to wit:

- i. The appropriation ordinance is a Supplemental Budget No. 1 for FY 2019;
- ii. A section stating that "Savings from 2012 5% Calamity Fund (Trust Fund) is hereby transferred to General Fund" should be added.
- iii. Change Other MOOE to any items in social services as found in 2019 Annual Budget.

Now, therefore, be it










