**EARNESTLY REQUESTING ATTY. SHARON L. DE CHAVEZ ALEDO, REGIONAL DIRECTOR, MARITIME INDUSTRY AUTHORITY (MARINA), REGIONAL OFFICE, BATANGAS CITY TO FACILITATE THE OPENING OF ROUTE FROM BULALACAO, ORIENTAL MINDORO TO LIPATA, CULASI, ANTIQUE AND VICE VERSA AS THE NEW MISSIONARY ROUTE FOR RORO VESSELS**

**“WHEREAS**, the Maritime Industry Authority is an agency under the Department of Transportation responsible for integrating the development, promotion and regulation of the maritime industry in the Philippines;

**“WHEREAS**, MARINA also provides effective regulation of shipping enterprises and permit the operation of domestic and overseas water carriers as they were granted the authority to issue Certificate of Public Convenience (CPC) ;

**“WHEREAS**, at present, Bulalacao, Oriental Mindoro has its RoRo Port with Fastcat vessels traversing a route from Bulalacao to Caticlan, Malay, Aklan taking a shorter time of only three (3) hours of travel where it is estimated that the route from Bulalacao to Lipata, Culasi, Antique has the same travel time;

**“WHEREAS**, the opening and subsequently the operation of Bulalacao to Lipata, Culasi, Antique route shall promote business partnership between the two provinces geared towards the social and economic development of both for shipment of goods and services be made easier; **Now, therefore, be it**


