**RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO CONDUCT OCULAR INSPECTION AND EVALUATION ON THE PROPOSED WATER IMPOUNDING PROJECT AT MAUJAO RIVER, BARANGAY MAUJAO, BULALACAO, ORIENTAL MINDORO FOR ITS EVENTUAL INCLUSION IN PRIORITY PROJECTS OF SAID NATIONAL GOVERNMENT AGENCY**

**“WHEREAS**, Section 17 (viii) of the Local Government Code provides that Local Government Unit shall provide basic services and facilities intended primarily to service the needs of the residents of the municipality;

**“WHEREAS**, Section 25 (b) and (d) of the Local Government Code defines the coordination and assistance of national government agencies to Local Government Units;

**“WHEREAS**, the DPWH’s functions include being “the engineering and construction arm of the government mandated to undertake the planning of infrastructures, such as roads and bridges, flood control, water resources projects and other public works”;

**“WHEREAS**, the Municipality of Bulalacao is an agricultural municipality which is prone to weather disturbance such as draught during dry season which affects agricultural production;

**“WHEREAS**, this project will retain water poured during rainy season and become water source for the next cropping to ensure continuous agricultural production in Barangay Maujao; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED To:** Earnestly request the Department of Public Works and Highways (DPWH) to conduct ocular inspection and evaluation on the proposed water impounding project at Maujao River, Barangay Maujao, Bulalacao, Oriental Mindoro for its eventual inclusion in priority projects of said national government agency;




