EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT THRU GOVERNOR HUMERLITO "BONZ" DOLOR TO EXTEND ASSISTANCE TO THE MUNICIPALITY OF BULALACAO IN ITS REFORESTATION PROGRAM

"WHEREAS, the onslaught of typhoons such as Tisoy on December 3, 2019 and super Typhoon Ursula on December 25, 2019 caused remarkable losses in agriculture, livestock and fishing industries including infrastructural facilities such as roads and bridges, school buildings, hospital and destruction of residential areas reached to 90% resulting to a feelings of deep grief and misfortune among the inhabitants;

"WHEREAS, trees were totally wiped-out and so the birds and other animals were destroyed including all other forest resources, soil erosion occurred and scarcity of water is already felt by the residents and such other forest disturbances;

"WHEREAS, at this moment of time, there is a dire need to implement a reforestation activity at the Municipality where the support and assistance of the Provincial Government is needed such as the provision of seedlings of durable and calamity resilient trees and such other assistance deemed necessary towards the immediate rehabilitation of its forest devastated by Typhoon Ursula; **Now, therefore, be it**
