**EARNESTLY REQUESTING HONORABLE ANTONIO "JOJO" S. PEREZ, JR., PROVINCIAL VICE GOVERNOR TO ALLOCATE NECESSARY FUNDS FOR THE CONSTRUCTION OF COVERED COURT AT SITIO CAMBAYANG, BARANGAY CABUGAO, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO.**

**"WHEREAS**, a multi-purpose covered court is an infrastructure facility in barangay which serves as an appropriate venue where the constituents of barangay gather for certain purpose like sports activities, conduct assembly meetings and distribution of assistance from different agencies even during heavy rains;

**"WHEREAS**, a covered court will also serves as an evacuation center during calamities providing a safe and temporary shelter to affected families;

**"WHEREAS**, the proposed covered court in Sitio Cambayang, Barangay Cabugao is a long way from the barangay proper that most of Hanunuo Mangyans are not capable to attend to some activities and programs due to limited means of transportation.

**"WHEREAS**, it is believed that with the intervention of the provincial government thru Vice Governor Antonio S. Perez, Jr., the construction of covered court at Sitio Cambayang, Barangay Cabugao, Bulalacao, Oriental Mindoro will be given his top priority ;


