**SPECIAL ORDINANCE NO. 08-04-066**

**SPECIAL ORDINANCE RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE MUNICIPAL MAYOR, ENGR. ERNILO C. VILLAS WITH MR. PETRONILO B. BUENDIA, GENERAL MANAGER, PHILIPPINE FISHERIES DEVELOPMENT AUTHORITY (PFDA) FOR THE CONSTRUCTION/IMPROVEMENT OF MUNICIPAL FISH PORT IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The Department of Agriculture (DA) through its fishery infrastructure arm, the Philippine Fisheries Development Authority (PFDA) is mandated to provide post-harvest infrastructure assistance to boost the development of the fishery industry in the country and has available funds for this matter;

**SEC. 2.** The PFDA had identified Bulalacao as one area where the establishment of a municipal fish port is needed in order to facilitate the proper unloading and handling of fish port and other fishery products in the locality;

**SEC. 3.** The PFDA had offered to improve/develop the fish port in Bulalacao, Oriental Mindoro with the use of funds from Ginintuang Masaganang Ani for Fisheries of the Department of Agriculture to which the Municipal Government had accepted the same;

**SEC. 4.** The Memorandum of Agreement entered into by and between the Municipal Mayor, Engr. Ernilo C. Villas with Mr. Petronilo B. Buendia, General Manager, Philippine Fisheries Development Authority (PFDA) for the construction/improvement of Municipal Fish Port in the Municipality of Bulalacao, Province of Oriental Mindoro is hereby ratified;

**SEC. 5.** This Special Ordinance shall take effect immediately.


**ENACTED** this 28<sup>th</sup> day of April, 2008, Bulalacao, Oriental Mindoro.






