SPECIAL ORDINANCE NO. 08-04-60

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BULALACAO DEVELOPMENT COOPERATIVE (BUDECO) REPRESENTED BY ITS MANAGER, MRS. JEAN A. CABAGAY FOR THE IMMEDIATE RELEASE OF THE AMOUNT OF TWENTY THOUSAND PESOS (PHP20,000.00) TAKEN FROM AID TO BUDECO UNDER THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE, SUPPLEMENTAL BUDGET NO. 1 TO BE USED FOR THE PURCHASE OF RICE FROM THE NATIONAL FOOD AUTHORITY (NFA)

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.


SECTION 1. In an effort to help arrest the problem on rice shortage which is the most serious issue faced by the country today, the Municipal Government of Bulalacao, Oriental Mindoro allocated the amount of Twenty Thousand Pesos (Php20,000.00) under the Municipal Social Welfare and Development Office, Supplemental Budget No. 1 to be used for the purchase of rice from NFA which shall be sold to identified indigent families at a very reasonable cost;

SEC. 2. The acquisition and distribution of NFA rice will be the sole responsibility of the BUDECO, it being the most recognized and reliable cooperative in the entire Municipality


SEC. 3. This Special Ordinance shall take effect immediately.


