ORDINANCE NO. 1

AN ORDINANCE STRICTLY PROHIBITING FISHERMEN COMING FROM OTHER PLACES TO CATCH FISH WITH THE USE OF DEEP SEA METHOD OF FISHING WITHIN THE TERRITORIAL LIMITS OF THE MUNICIPAL WATERS OF BULALACAO, ORIENTAL MINDORO WITHOUT FIRST SECURING A SPECIAL PERMIT FROM THE MUNICIPAL MAYOR AND SHALL PROVIDE FINES AND PUNISHMENT FOR VIOLATION THEREOF

WHEREAS, it has been observed that fishermen from other places are coming to catch fish with the use of deep sea method of fishing within the territorial limits of the Municipal waters of this municipality;

WHEREAS, these fishermen caught abundance of fish in the municipal waters of this town, but not pay regularly the corresponding fees due to lack of Ordinance or fishery laws, rules and regulations;

WHEREAS, in order to regulate the payment of fees of fishermen coming to catch fish with the use of deep sea method of fishing, the Sangguniang Bayan hereby ordina that;

SECTION 1. It is strictly prohibited for fishermen from other places coming to catch fish the use of basnig or deep sea method of fishing within the territorial limits of the Municipal Waters of Bulalacao unless the following have been previously secured and complied with, as follows;

- a) Authority to operate and catch fish under a " SPECIAL PERMIT granted by the Municipal Mayor;
- b) A special Permit fee of ₱ 300,00 per month to be paid to the Municipal Treasurer or his authorized representative;
- c) Ten (₱ 10,00) privilege fee for every day of stay in the shorelines within the jurisdiction of Bulalacao;

SECTION 2. Any person caught violation this Ordinance or parts hereof, shall upon conviction be punished by a fine of ₱ 500,00 to ₱ 1,000.00 or an imprisonment of one (1) to six month, or both such fine and imprisonment at the discretion of the court;

SECTION 3. Any such violation of this Ordinance maybe settled extrajudicially upon payment of a compromise fee ₱ 500,00 to the Municipal Treasurer;


SECTION 4. Ordinance inconsistent with the provisions of this Ordinance (are hereby Ordinance) are hereby repealed or modified accordingly;

SECTION 5. This Ordinance shall take effect 10 days upon its approval.

RESOLVED, FURTHER, that copies of this Ordinance be furnished, the Sangguniang Panlalawigan, Calapan, Oriental Mindoro, the Ministry of Agriculture and food, the Bureau of Fisheries & Aquatic Resources, Manila for their information comment, legal opinion regarding the fisheries law, rules and regulations;
