YAP, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) FOR THE CONSTRUCTION AND REHABILITATION OF BARANGAY SAN ROQUE TO SITIO DANGKALAN FARM TO MARKET ROAD SITUATED IN BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE AMOUNT OF TEN MILLION PESOS (PHP10M)**


**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

Yap for the construction and rehabilitation of Barangay San Roque to Sitio Dangkalan Farm to Market Road situated in Barangay San Roque, Municipality of Bulalacao, Oriental Mindoro in the amount of Ten Million Pesos (Php10M);

SEC. 2. This special ordinance shall take effect immediately.


