ORDINANCE NO. 03-05-030-A

AN ORDINANCE ADOPTING PRESIDENTIAL PROCLAMATION NO. 342 ENTITLED "DECLARING THE LAST SATURDAY OF MARCH 2003 AND THE THIRD SATURDAY OF OCTOBER 2003 AND EVERY YEAR THEREAFTER AS BARANGAY ASSEMBLY DAY"

WHEREAS, as the basic political unit, the Barangay serves as the primary planning and implementing unit of government policies, plans, programs, projects and activities in the community, and as a forum wherein the collective views of the people may be expressed, crystallized and considered, and where disputes may be amicably settled;

WHEREAS, Section 397 of the Local Government Code of 1991 requires the so-called Barangay Assembly, composed of all persons who are actual residents of the Barangay for at least six (6) months, fifteen years of age or over, citizens of the Philippines, and duly registered in the list of Barangay Assembly members, to meet at least twice a year to hear and discuss the semestral report of the Sangguniang Barangay concerning its activities and finances as well as problems affecting the Barangay;

WHEREAS, the Barangay Assembly has the following powers as mandated by Section 398 of the Local Government Code of 1991;

- i. to initiate legislative process by recommending to the Sangguniang Barangay the adoption of measures for the welfare of the Barangay concerned;
- ii. to decide on the adoption of initiative as a legal process whereby the registered voters of the Barangay may directly propose, enact, or amend any ordinance;
- iii. to hear and pass upon the semestral report of the Sangguniang Barangay concerning activities and finances;

WHEREAS, Proclamation No. 342 has three-fold objectives, namely;

- a. to strictly comply with the requirements of the Local Government Code on having a **TWICE A YEAR** Barangay Assembly meeting;
- b. to diligently fulfill the purpose thereof;
- c. to emphasize the role and importance of the Barangay in the government;


NOW, THEREFORE, on motion of Councilor Juan L. Salas, Sr. duly seconded by Councilor Cesar P. Lantin;


BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


SECTION 1. There is hereby adopted Presidential Proclamation No. 342 entitled "Declaring the Last Saturday of March 2003 and the Third Saturday of October 2003 and Every Year thereafter as Barangay Assembly Day" and further enjoining all Punong Barangays to convene their respective Barangay Assemblies on the date herein mentioned;


SEC. 2. This Ordinance shall take effect upon approval.


