ORDINANCE NO. 06-01-061

**AN ORDINANCE COVERING THE BULALACAO BAY DEVELOPMENT
PROJECT BE DECLARED AS MUNICIPAL BAY PARK AND PLAZA**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

SECTION 1. Regulated Acts:

In view of the fact that the Municipality now has ample powers over tourism, it is hereby declared that the present area covering Bulalacao Bay Development Project as Municipal Bay Park and Plaza;

SECTION 2. Fund Sources:

The funds to be used for the devolved basic tourism services and facilities may be categorized into three:


- the share of Local Government Units (LGU) from National taxes;
- Local revenues and;
- Funding support from the central government;

SECTION 3. Special Oversight Committee is hereby created composed of the Municipal Tourism Officer as Chairman, The Municipal Planning and Coordinator, The Municipal Engineer, The Municipal Health Officer, The Chairman of Committee on Tourism of Sangguniang Bayan, The Punong Barangay of Poblacion and The chief of Police as members which shall plan and


oversee the expeditious implementation of the provisions of this Ordinance, whose recommendations shall be submitted to the Office of the Municipal Mayor and Sangguniang Bayan within ninety (90) days for their approval;


SECTION 4. This ordinance shall take effect immediately.






