ORDINANCE NO. 08 - 10 - 89

**REQUIRING FISH DEALERS AND SHIPPERS OF AQUAMARINE
 PRODUCE TO UNLOAD ALL THEIR PRODUCTS AT THE
 MUNICIPAL FISH LANDING PORT OF BULALACAO, ORIENTAL
 MINDORO AT SITIO KAW-AYAN, BARANGAY POBLACION FOR
 INSPECTION AND TAXATION PURPOSES**

Sponsor: Councilor Senen C. Familara

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to facilitate water transportation system to fishermen and passengers plying to and from nearby islands and municipalities, the Municipal Government of Bulalacao constructed the Municipal Fish Landing Port at Sitio Kaw-Ayan, Barangay Poblacion;

SEC. 2. Fishermen, fish dealers and shippers of aquamarine produce are required to unload all their products at the Municipal Fish Landing Port of Bulalacao, Oriental Mindoro at Sitio Kaw-Ayan, Barangay Poblacion for inspection and taxation purposes and it shall be unlawful to unload fish in any other place except in the port mentioned herein;

SEC. 3. Violation of this Ordinance or part hereof shall be fined the amount of Five Hundred Pesos (Php500.00) to One Thousand Pesos (Php1,000.00) or an imprisonment of ten (10) to thirty (30) days or both such fine and imprisonment at the discretion of the Court;

SEC. 4. Ordinance inconsistent with the provision of this ordinance are hereby repealed or modified accordingly;


SEC. 5. EFFECTIVITY. This Ordinance shall take effect immediately.

ENACTED this 13th day of October, 2008, Bulalacao, Oriental Mindoro.


