SPECIAL ORDINANCE NO. 10-02-52

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) FOR GRANTING THE AMOUNT OF FIVE MILLION PESOS (PHP5M) TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM MOUNTAIN SIDE NATIONAL HIGHWAY TO RECODO, ALL OF BARANGAY MAUJAO, THIS MUNICIPALITY AND RATIFYING THE SAME CONTRACT



BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


SECTION 1. The Municipal Mayor, the Honorable Emilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Honorable Arthur C. Yap, Secretary, Department of Agriculture (DA) for granting the amount of Five Million Pesos (Php5M) to the Municipality of Bulalacao, Oriental Mindoro to be used for the construction/rehabilitation of Farm to Market Road from Mountain Side National Highway to Recodo, all of Barangay Maujao, and to ratify the same contract;

SEC. 2. This Special Ordinance shall take effect immediately.


