**SPECIAL ORDINANCE NO. 11-07-33**

**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH JOLLIBBEE FOUNDATION, INC., ZUELLIG FAMILY FOUNDATION AND THE DEPARTMENT OF EDUCATION FOR THE IMPLEMENTATION OF BUSOG, LUSOG, TALINO (BLT) PROGRAM WHICH AIMS TO IMPROVE THE NUTRITIONAL STATUS OF IDENTIFIED UNDERNOURISHED PUBLIC ELEMENTARY PUPILS AND MITIGATE HUNGER THAT LEAD TO PUPIL'S LOW SCHOOL ATTENDANCE AND HIGH DROP-OUT RATES**

**SECTION 1.** The Municipal Mayor, the Honorable Emilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with Jollibbee Foundation, Inc., Zuellig Family Foundation and the Department of Education for the implementation of Busog, Lusog, Talino (BLT) Program which aims to improve the nutritional status of identified undernourished public elementary pupils and mitigate hunger that lead to pupil's low school attendance and high drop-out rates;


**SEC. 2.** This special ordinance shall take effect immediately.






